




P/O D. STANLEY 46, being first duly cautioned and sworn, deposes and says that

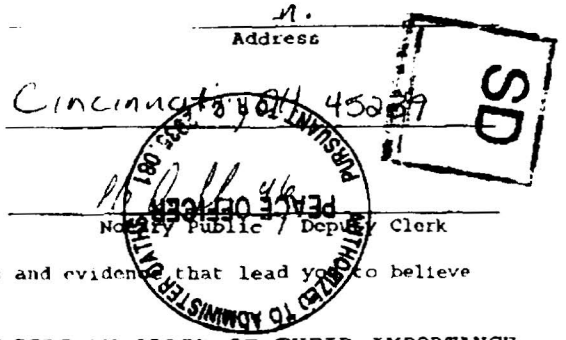
